
- 2.0 The tender will be governed by the "Instructions to Bidder" at Annexure - I, "Model Contract and General Contract Conditions" at Annexure - II, "Scope of Work" at Annexure - III, "Bid Evaluation Criteria" at Annexure - IV, Annexure-V "Schedule of Rates".
- 3.0 Resolution of clarifications / exceptions / deviations to tender terms & conditions and specifications:

ranking in tender, the bid will be rejected and ONGC may consider to debar the bidder from participating against its future tenders.

The physical documents should be submitted at either of the following places:

- 8.0 Price Bids submitted in physical form against e-procurement tenders shall not be given any cognizance.
- 9.0 Bid cannot be submitted after the submission deadline is reached. The system time that will be displayed on e-procurement web page shall decide the submission deadline. Bidders are advised in their own interest to ensure that bid is uploaded in the system well before the closing date and time of the bid.
- 10.0 **Pre-Bid Conference:** The parties who have purchased the tender document may seek clarification on condition of tender document and upload their queries in C-folder - Bidders correspondence area - pre-bid through e-procurement SRM website by 17.06.2014 at 2359 IST HRS. Pre-Bid Conference will be held on 19.06.2014 at 1500 Hrs. (IST) in the 3rd Floor Conference Room by General Manager-Incharge-MM-Services, wherein ONGC's position on the issues raised by the parties would be discussed / clarified. The bidders are informed that the pre-bid conference is not the platform to propose changes / modification to standard clauses of the Annexure - I: (Instructions to Bidders) and Annexure - II (General Conditions of Contract (GCC) and bidders should accept / confirm the same without any exception / deviation.
- 10.1 Bidders are advised to depute their authorized and accredited representative of appropriate rank to attend pre-bid conference to take decision across the table.
- 10.2 Any modification to the tender documents listed above, which may become necessary as a result of the pre-bid meeting, shall be made by the Corporation exclusively through issuance of an amendment to tender documents and not through record notes of the pre-bid meeting.
- 10.3 Non-attendance at the pre-bid meeting shall not be a cause for disqualification of a bidder.
- 11.0 ONGC expects the bidders to comply with the tender specifications / conditions, which would be frozen after pre-bid conference. Tenders not complying with tender conditions and not conforming to tender specifications may result in the rejection of its bid without seeking any clarifications.
- 12.0 Bidders also to note that one agent cannot represent two bidders.
- 13.0 E-Mail / Telex / telegraphic / Fax / Xerox / Photocopy offers will be rejected.
- 14.0 In case of any unscheduled holiday on prescribed closing / opening date, the next working day will be the prescribed date of closing / opening of tender.
- 15.0 The bid & Bid Bond should be valid for a period of 90 days & 120 Days respectively from the date of techno-commercial opening date.
- 17.0 ONGC reserves the right to cancel at its own discretion any / all bids received without assigning any reason.
